# **Extended Warranty Agreement**

## For the AlphaESS Commercial and Industrial Product Series

### **Products**

Subject to the terms and conditions detailed below, AlphaESS provides a voluntary product Extended warranty (the Warranty) for the following BESS systems (the Products):

• Storion-H30-G3, Storion-H50-G3, STORION-LC-TB125 system.

#### **Parties**

This Extended Warranty Agreement (the 'Agreement') is entered into between:

- - Alpha ESS Europe GmbH (hereinafter referred to as 'Alpha ESS' or the 'Provider'), and
- - The purchaser/end user of the Product (hereinafter referred to as the 'Customer').

# Scope of Warranty

This Agreement provides an optional extension of the warranty period for the AlphaESS energy storage system components mentioned above, excluding batteries. The Extended Warranty applies only to the following components, while battery and other components products remain governed exclusively by the Standard Warranty:

#### Commencement and Duration

• The Extended Warranty must be purchased within six (6) months after installation or within twelve (12) months after the production date, whichever occurs first.

• The Extended Warranty shall begin immediately upon expiration of the Standard 5-Year Product Warranty..

• The Extended Warranty extends the coverage by five (5) additional years, resulting in

a total warranty period of ten (10) years for the PCS.

**Scope of Coverage** 

The Extended Warranty provides coverage only for defects in materials and workmanship of

the PCS under normal use and operating conditions.

AlphaESS will, at its sole discretion, repair or replace the defective PCS with a new or

refurbished product meeting or exceeding the original specifications.

The replacement product will inherit the remaining term of the Extended Warranty and will

not restart a new warranty period.

**Limitations of Coverage** 

This Extended Warranty covers hardware replacement only. AlphaESS does not cover any

labor or service costs, including but not limited to:

On-site inspection, troubleshooting, removal, reinstallation, or recommissioning.

• Travel, accommodation, or daily allowances for service personnel.

Lifting or handling tools such as cranes or forklifts.

Administrative, customs, or logistics costs related to warranty services.

All such costs are the sole responsibility of the Customer.

**Preconditions** 

The validity of this Extended Warranty is subject to compliance with the following conditions:

The PCS must be installed and commissioned by a certified installer or authorized

AlphaESS distributor.

• The product must be registered in AlphaCloud within thirty (30) days after commission.

• Operation and maintenance must be performed strictly in accordance with AlphaESS

manuals and technical specifications.

Failure to meet these conditions may render the Extended Warranty null and void.

**Exclusions** 

The exclusions defined in the AlphaESS Standard Warranty apply equally to this Extended

Warranty.In addition, this Extended Warranty does not cover:

Any component other than the PCS.

• Any defect caused by improper installation, misuse, accident, or unauthorized

modification.

• Indirect or consequential damages such as loss of energy production, profit, or data.

• Transportation or labor costs for units that are found to be free of defects.

Claims Process

Warranty claim procedures, required documentation, and replacement rules shall follow the

provisions set out in the AlphaESS Standard Warranty. This includes, but is not limited to,

timely reporting, provision of serial numbers, commissioning reports, proof of purchase, and

return of defective components within the prescribed period.

**Liability Limitation** 

The limitations of liability defined in the AlphaESS Standard Warranty shall apply equally to

this Extended Warranty. AlphaESS shall not be liable for indirect, incidental, or consequential

damages. Maximum liability shall not exceed the purchase value of the covered component.

**Governing Law and Jurisdiction** 

This Agreement shall be governed by and construed in accordance with the laws of Germany.

The competent courts in Frankfurt am Main, Germany, shall have jurisdiction unless

mandatory law provides otherwise.
